G Emergency Committee PC 20th April 2020

As you will know from the previous Minutes the Emergency Committee are reviewing the current version of the Emergency plan and whilst it is not yet finished and this current situation is not something we could have anticipated, the actions which are detailed have been enacted and are proving to be very effective, with the help of many volunteers from all over the community.

From the first action on 13th March when the Parish Council sent out letters to the Parish Wardens (who are volunteers that have agreed to look out for the elderly and vulnerable people in their streets and local areas) suggesting that they could be called upon in the near future to the end of the month where we are in lock down with no visible end date.

On the 16th March the regular PC meeting was held – face to face for the last time in the foreseeable future – to agree some spending powers should they be required for the local area, closely followed on the 17th by news that the Bell and Crown and Anchor were closed but were doing takeaways; the Brewery was closed but would do deliveries and Meals on Wheels were cancelling their service but the Bell stepped in and agreed to cook and deliver them.

This was also the day the villages started to galvanise into action and over the next two days there was lots of activity – Alison Foale set up a WhatsApp Group for the large number of volunteers who had come forward saying they would be available to help with shopping or collecting prescriptions, the different lists of helpers were merged and those in possible need identified; Ashely De Safrin volunteered to run a "shop" in the Axford Village hall; a letter went to Danny Kruger our MP concerning village shops staying open and the Good Neighbour leaflet was published on the Ramsbury.org website.

On 19th March the PC made the decision to postpone the Boundary Walk and the Brewery offered a small supply of hand sanitizer which was given to the Post Office and Midway Stores for their use. The PC Clerk cancelled the Internal Auditor meeting to respect the new government rules and over the next few days volunteer lists were updated and shared, boxes of gloves sourced for the volunteers and the shops and discussion started about the preparation of the mail drop to all houses in Ramsbury and Axford updating the community with what was happening locally.

On the 25th and 26th the leaflets were distributed and the Bell, Crown & Anchor and Brewery all stopped takeaways and deliveries. Sue Brady offered home cooked food on a Tuesday and Thursday collected and distributed by Di and Paul Trickey and Caroline Telwright offered fresh homemade soup. By the 31st Sue Brady had ceased with her service (although she is now again able to supply)

In April we have some advice from the National Association of Parish Councils re holding virtual meetings and at the same time been advised that the PC funding will not be amended to take into account any additional spending on COVID-19 services.

As we know there is to be a further lockdown period of 3 weeks, we continue to monitor the situation and will hold a debrief when it is possible to.

SG added that we had had two requests from social services for specific residents and both had been satisfied. Meals on Wheels had received 20 meals FOC from Cook in Marlborough-some were distributed and some given to Matt from the Bell who is still doing Meals on Wheels. Major thanks to Elaine and Shirley in the Post Office for deliveries and help and Alison Foale for help with co-ordinating volunteers. Lots of good feedback from leaflet distributed by volunteers on March 25th
