Not sure the PC are aware that the road sign on Union Street (Newtown end) disappeared about a year ago and has to date not been replaced? There is also a very old and faded 'Neighbourhood Watch' sign on the post which perhaps should be taken down.

The WC engineer was supposed to review the flooding on the road next to the lay by on Whittonditch Road to assess what could be done to improve drainage. I'm conscious that winter is upon us and nothing has been done thus far. House number 21, adjacent to the field suffers from the flooding as the footpath into their home becomes water logged and there are 2 small children living there. Not ideal conditions for a young family. Last year the drains in the vicinity of the lay by were cleared by the council. I wonder if you can arrange for this to occur again?

Fly tipping on Crowood; we were told by a neighbour that she had spotted plastic bags and plastic industrial bottles along Crowood, the same place where the dirty nappies had been left some months ago. We mentioned this to LJ in passing that weekend. Mark then raised a ticket with WC and by the following weekend the litter had been removed. This matter was resolved in record time.
