- (i) By 2022 15 of the 21 towns in Wiltshire will have taken on their own grass cutting and litter picking, (WC spend £2.8million a year on litter picking which could be spent on other things) but they will continue to carry out the statutory grass cutting in the villages.
- (ii) There is a new gully (drain) service to provide gully cleaning in villages. Gullys have to be identified and reported and they should be cleared within 6 weeks.
