MINUTES OF THE PARISH COUNCIL MEETING HELD ON MONDAY 15TH OCTOBER 2018 AT RAMSBURY MEMORIAL HALL

Present- S Glass Chairman (SG), Carol Standage, Clerk (CS), M Holdsworth, Minutes Secretary (MH) Christopher Payne (CP), George Hawes (GH), Diann Barnett (DB), Ron Young (RY), Graeme Fearon (GF), Helen Lloyd (HL),D Edwards (DE), C Morgan (CM). Three members of the public.

- 2 DISCLOSURES OF INTEREST None
- 3 MINUTES of the meeting held September 17th 2018 (previously circulated) for approval
 - (i) P 1935 A2954 "If he needs to use any of the information...." to be changed to "if he needs to publish any of the information....."
 - (ii) P1397 Item 13 "CP has contacted Leonie for letters..... "to be changed to "CP contacted W C for letters....."
 - (iii) Minutes were then approved and signed . Pro RY, sec., DB. All agreed
- 4 MATTERS ARISING from the minutes not itemised separately:
 - **Changes to wards in Wiltshire** SG told Council that there appears to be no change to the size of the Ramsbury & Aldbourne ward as there are approx. 4,000 electors which is the number the consultation is aiming at for each ward.
- Claire Costello from Froxfield PC will speak about the Memorial Wood project at Rudge Farm. C Costello was unable to attend the meeting. The site of the Memorial Stone (which was discussed at the September meeting) is on P Wilson's land and is in Ramsbury parish. SG proposed that the Parish Council would be responsible for the Stone. All agreed. There is to be an Open evening and exhibition on 24th Oct at Ramsbury British Legion 7.30pm for 8pm. Tree planting will take place on 10th Nov.
- 6. SG asked that Item 10 Parking in Isles Rd & Back Lane be brought forward . 2 governors from the school were present at the meeting. There had been several complaints about school parking see A3004, A3006, A3014, A3017. DB had been in contact with Andrew Jack from WC and it was suggested that the Road Safety & Education Officer from WC work with the school on a Travel Plan. SG suggested that the school could ask parents to take on board a similar "contract" to the parking contract that the Pre School have. SG also suggested that parents be asked to drive one way along Back Lane and then carry on to the end of Back Lane (either West to East or East to West) as this would do away with the reason to reverse into driveways or Loves Lane or Isles Road to turn round. There is a danger aspect in reversing, especially in Isles Road.
 - SG had had a meeting with Martin Cook (WC Highways) in the morning of 15th Oct.. He has authorised white lines to be painted across the Mair's driveway (Mardle House), a white line to replace the bollards on the road at the bottom of Isles Rd by the hedge and a yellow zig zag line on the road along the front of the Pre- School and round the corner up to the entrance to the school car park. The Governors will take these suggestions back to the school and the situation will be reviewed in 3 months time.
- 7. SG asked that Item 29 be brought forward Application for consideration for recruitment to Parish Council. The Clerk had received an application from Kate Abbot (who was present at the meeting). KA Was asked to leave the room whilst Councillors discussed the application. SG proposed the application be accepted sec DE. **All agreed.**
 - Kate Abbot was welcomed to the Parish Council and took part in the rest of the meeting **Action:Clerk to inform WC and prepare documents for signature at the next meeting.**
